Sleepover	This support item includes up to two hours of active support provided to the participant for the duration of the period. It is necessary to book a minimum of four-hour shift either prior to or following the sleepover.
	The worker must be provided with a separate room with a bed, clean linen, and facilities. The worker is allowed to sleep when they are not providing support.
Transport	A per kilometre rate is charged when using Advanced Care or Support Worker personal motor vehicles within the duration of client services for participant purposes.
	Applies to the time and per kilometre distance travelled by an Advanced Care Home Care worker to a participant's service.
Travel Time Charges	However, the maximum chargeable time for each service is limited to 30 minutes in non-remote areas. The charge for this travel time will be calculated based on the applicable hourly rate of the support being provided during the visit.

Cancellations	Where the service is cancelled without two (2) clear business days' notice prior to the scheduled service start time, a fee of 100% of the requested support will apply.
Service Duration	Minimum of a 2-hour service.  Services are thereafter billed in 15-minute increments.
High Intensity Supports	A Higher Intensity Support rate is charged when Advanced Care Home Care Workers are required to provide these supports to participants.
	This fee applies to all NDIS participants on commencement of the first service agreement with a service provider where they receive at least 20 hours of personal care/community access support per month.
Establishment Fees for Personal Care/Participation	This one-time payment is to cover non-ongoing costs for providers establishing arrangements and assisting participants in implementing their plan.
Supports	The establishment fee is claimable by the provider who assists the participant with the implementation of their NDIS Plan, delivers a minimum of 20 hours per month of personal care/community access support and has made an agreement with the participant to supply these services.
